ADDENDUM TO THE CONSTITUTION OF THE JEEP CLUB SOUTH AFRICA - (KZN CHAPTER)

1. **CONSTITUTION OF THE JEEP CLUB SOUTH AFRICA**

This document must be read in conjunction with the Constitution of the Jeep Club South Africa, also referred to as the "Jeep Club SA", "Jeep Club ZA" or the "Jeep Club RSA", here forth referred to as the "Club".
- 1.1 In the case of any dispute as to the application or interpretation of any clause in this addendum the clauses in the Constitution of the Jeep Club South Africa will take preference and disputes shall be settled by resolution of the Club Management Committee, whose decision on such matters shall be final and binding on all chapters and club members.
- 1.2 All clauses in the Constitution of the Jeep Club South Africa will be applicable with the following clarifications to clauses as referred to.
2. **NAME**

The name of this organisation will be the "Jeep Club South Africa - KZN Chapter", a chapter / branch of the "Jeep Club South Africa", and here forth referred to as the "Chapter".
3. **DEFINITION OF WORDS**

In this addendum meaning;

 - 3.1 "Chapter" - the Jeep Club South Africa - KZN Chapter, a chapter / branch of the Jeep Club South Africa.
 - 3.2 "Chapter Management Committee" - the management committee of the Jeep Club South Africa - KZN Chapter responsible for organising this chapter.
4. **NUMBER OF MEMBERS (Clause 8)**
 - 4.1 There is no restriction on the maximum number of members in the Chapter.
 - 4.2 At all times, the minimum number of members may not be less than 5 (five).
5. **REGISTRATION AND ANNUAL MEMBERSHIP FEES (Clause 13)**
 - 5.1 A Club registration fee, as determined by the Club Management Committee, will be payable by every new member / applicant. This amount is payable on application and will be retained by the Chapter.
 - 5.2 An annual Chapter Club membership fee, as determined by the Management Committee, will be payable by each member and will be retained by the Chapter.

- 5.3 An annual Chapter registration fee as determined by the Club Management Committee, based on the number of members registered at a chapter during the previous year, with a minimum annual fee, may be payable to the Jeep Club South Africa. This registration fee may be recovered from the Chapter members as part of their annual membership fee.
- 6. GENERAL MEETINGS (Clause 18)**
- 6.1 **ANNUAL GENERAL MEETING (AGM) (Clause 18.1)**
- 6.1.1 The Chapter will conduct a general meeting once a year, which will be known as the Chapter Annual General Meeting and be held in addition to any other meeting that may be held during that year. The Chapter Annual General Meeting may not take place later than 30 (thirty) days after the Club Annual General Meeting.
- 6.1.2 The financial year ends on the last day of October of every year.
- 6.1.3 Representatives of all chapters are requested to attend the Club Annual General Meeting.
- 7. DISSOLUTION (Clause 25)**
- The Chapter will be dissolved if a special resolution to do so is accepted at a Special Chapter Meeting called to dissolve the Chapter.
